Sir,

The following submissions are very humbly made on the subject cited above :

The college is one of the oldest (Established in 1956) teacher training colleges catering largely to the needs of rural students of this educationally backward region of Punjab. It is covered under Grant-in-Aid scheme of Government of Punjab and is permanently affiliated to Panjab University, Chandigarh. It is also listed in UGC list under 2(f) and 12 (b) of UGC Act.

- The college was conducting one year B.Ed course with 100 seats as per approval given under your order no. F-3/P.B.-17/B.Ed./2000/5120 dated 26.07.2000 (copy attached, ANNEXURE-I), but in two year B.Ed programme, the college reduced the intake of students to 50 from already sanctioned strength of 100. So, there was no need of additional built-up area and additional infrastructure. The institution complied with the requirements laid down in the revised norms and standards of 2014. Two affidavits bearing No. T 190908 dated 10.01.2015 (ANNEXURE-II) and T 197567 dated 28.02.2015 (ANNEXURE-III) had been submitted regarding the same under registered letter No. KHC/Edu./MKS/1029 and KHC/Edu./MKS/1069 respectively.
- The college is adhering to staff norms as per regulations, 2014, the detail of the staff along with their brief bio-data is uploaded on the college website www.kcemkt.org
- The selections for the two positions of faculty under grant in aid scheme of Govt. of Punjab namely Assistant Professor in Education (1) and Librarian (1) were filled but the writ petitions regarding their appointments are pending in honorable Punjab and Haryana high court.
- There are two FDRs with following details:

- In reference to status of composite institution as per clause-2(b) and 8(1) of NCTE, Regulations, 2014, Panjab University, Chandigarh was not allowing B.Ed colleges to start undergraduate course in liberal arts or any other stream under the same college in order to become a composite institution. So, this college is going to be retained as college of education only. The management is planning to start NTT (2year), Diploma in NTT (1year) and Early Childhood Care and Education (1 year Diploma) from the upcoming session. Also, the Management is running a multi faculty degree college also, namely Dashmesh Khalsa College, Muksar (Punjab) which is running B.A, M.A. and Computer Courses. Both these colleges are in one campus and the institution may be treated as a composite one. In near future, management may propose to initiate integrated programme in education depending upon the training and employment needs of the area.

ORDER

In exercise of the powers vested under Section 14(3)(a) of the National Council for Teacher Education (NCTE) Act, 1993, the Northern Regional Committee grants recognition to Khalsa College of Education, Muktsar - 152026, (Punjab) for B.Ed. of One year from the academic session 2000-2001 with an annual intake of 100 (One Hundred) students, subject to fulfilling the following conditions:

1. All such teachers already appointed who do not fulfil the NCTE norms shall acquire the qualifications as per the norms within a period of two years of this order.
2. The institution shall ensure library, laboratories and other instructional infrastructure as per the NCTE norms.
3. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating University/State Government.
4. Tuition fee and other fees will be charged from the students as per the norms of the affiliating University/State Government till such time NCTE regulations in respect of fee structure come into force.
5. Curriculum transaction, including practical work/activities, should be organised as per the norms and standards for the course and the requirements of the affiliating University/Examining body.
6. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
7. The institution, if unaided, shall maintain endowment and reserve fund as per NCTE norms.
8. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The Performance Appraisal Report should inter alia give the extent of compliance of the conditions indicated at 1 to 7 above.
